Subject	All Wales Integrated Offender Management (IOM) Senior Analyst.
Summary	To record the decision of the Police and Crime Commissioner to contribute to the post of All Wales Integrated Offender Management (IOM) Senior Analyst.

DECISION

- The post of All Wales Integrated Offender Management (IOM) Senior Analyst was created by Her Majesty's Prison and Probation Service (HMPPS), the four Welsh Police and Crime Commissioners and Welsh Government, to support the integrated offender management arrangements by building and sustaining professional strategic and tactical capability serving all partners across Wales.

The post commenced in January 2021 for a 24-month period. Each partner committed to make a financial contribution to cover the salary and on costs of the post, which were estimated to be £100,594.56 over the 2 years.

Each partner agreed the financial contribution at the All Wales Criminal Justice Board in July 2019. Gwent Police and Crime Commissioner's contribution for the period January 2021 to January 2023 was £16,765.76.

The post has been vacant since November 2021 and the contribution made by Gwent up to June 2022 was £5,496.17.

A decision has been made by partners to recruit into the post again and new 24-month contract is to be awarded. Each partner has been asked to contribute estimated contributions as outlined in the table below.
